Facilities Master Plan

- Through a formal Request for Qualifications (RFQ) Process, LTUSD selected Studio W Architects in August, 2021 to identify the numerous facility and site needs of the District and to develop a Facilities Master Plan.
- A Community Facility Vision Meeting was held on September 29, 2021 to obtain input from community partners on the needs of LTUSD's school sites.
- A Facilities Planning Advisory Committee, whose membership is comprised of over ten District and Community stakeholders, was tasked with focusing on a conditions assessment and campus priorities.
- Meanwhile, the District contracted with Isom & Associates to conduct a Community Bond Survey (February) to determine if voters would support a bond and at what rate.
- On March 24, 2022 a Facilities Master Plan was adopted by the Board of Education with slight revisions to the priorities based on a Bond Survey of the community.

CODE HEALTH & SAFETY



- » Create a **single point of access** with visual connectivity to the street by properly locating or reconfiguring administration
- » Modernize **parking and drop-off zones** to consider a barrier separating the drop-off area from parking areas per California Department of Education's requirements
- » Repair damaged **paving and walkways**
- » Repair aging **infrastructure** and **mechanical, electrical and plumbing systems** for proper operation and sizing
- » Repair exterior **roofing and siding** to protect interior finishes, furnishings and equipment
- » Consider proper ventilation and indoor air flow for improved **indoor air quality**
- » Replace exterior **window and door systems** with proper insulative values and protective measures (locking devices and shades)
- » Replace **fire alarm, clock/bell and speaker systems** to properly notify occupants of danger

Measure K - Priorities of the FMP

Measure K will be is on the ballot for election in November at the Rate of \$35 per \$100,000 per year of assessed property value. If passed, Measure K will fund critical facility improvements at South Lake Tahoe schools as described in the Facilities Master Plan, including:


- Safety improvements to ensure safe school sites
- Repairing/replacing leaky roofs
- Updating inadequate electrical systems
- Replacing outdated heating, ventilation and air-conditioning systems
- Making health, safety and handicapped accessibility improvements
- Replacing deteriorating plumbing systems
- Improving and modernizing learning environments to support today's student




TAX TOLERANCES SURVEY 2022


\$60 year




\$50 year

Measure K Makes Financial Sense and Protects Taxpayers

- By law, spending must be reviewed and annually audited by an independent citizens' oversight committee.
- All bond funds must be spent locally and cannot be taken by the State.
- Funds are required to be spent only on our schools, not for administrator or teacher salaries.



Why Now?

If the District decided not to do a bond in 2022, the earliest it could do a bond would be 2024, which means money in 2025, and the first major facility improvement not until 2026. Our community's schools need our attention now.

The District has been responsible stewards, routinely maintaining and fully utilizing classrooms and facilities. Yet, much of the facilities are aging and need to be fixed, updated, and modernized. The time has come to reinvest in our community's greatest assets – local children and the schools they attend. Measure K will upgrade school facilities to create safe and healthy learning environments. It will renovate classrooms, restrooms, and other school facilities, which will improve the education of local students, and maintain the quality of our community.
