# Guidance

This document's intent is to provide overall guidance for the opening of the 2020/2021 school year. More detailed plans will be developed by each school site and District department. LTUSD is committed to the following guiding principles:

**Indicators-** The conditions under which the District will move between learning models. The advice from the the Governor's Office, CDE, CDPH, EDCHD, and community health and safety partners will be used to make these decisions.

**Instructional Models -** In-class learning provides an effective learning environment for all students to meet learning objectives and access instructional support from teachers and support staff. However there is recognition that health and safety implications will provide a need for multiple options.

**Academic Success and Social Emotional Support** - Both In-Person and Distance learning must be robust and offer the same educational access, opportunity, and continuity. Relationships and in-person connectivity are a critical component of social development for students.

**Health and Safety** - The health and safety of staff and students is the single highest priority. Health protocols, screening procedures, and materials/equipment needs are a priority.

**Governance and Operations** - Consideration of facilities and grounds, maintenance, food services, transportation, and Education Center operations.

**Special Education and Special Populations** - The ultimate goal is to support the development and implementation of a plan for special education students to return to school, while doing everything possible to ensure the health and safety of our students, staff and community.



# Introduction

## LTUSD Indicators for Partial or Total Closures

LTUSD Indicators for Partial or Total Closures of schools and classrooms to in-person learning.

The following phases were developed in collaboration with the LTUSD taskforce and local health experts. The guidance allows for LTUSD to implement a risk assessment of the COVID-19 Pandemic impact on the local community, analyze community spread, and assess the necessary safety protocols needed to strategically move between phases of distance and in-person learning. State guidance provided by CDE, CDPH, and CalOSHA provide the necessary specific parameters which allow the District to move between distance, hybrid in-person learning, and traditional instructional models. These guidelines will be continuously reviewed and updated as new information is available. Each phase presumes a six week period of instruction (or ½ trimester) in a learning model, with reassessment two weeks prior to the end of each six week period to assess the ability to pivot to a different phase, or continue in the current phase. This allows for adequate planning time for our community, our families, our staff, and our students while ensuring the best continuous learning opportunities.

# Instructional Models

LTUSD is committed to reopening schools in a Traditional Model as soon as this can safely be done and with the recommendation and approval of the El Dorado County Public Health Department (EDCPHD). At the time of this planning document, Social Distancing Guidelines, increases in COVID-19 cases and community spread are requiring modified school reopening models. The following Models maximize in person instruction while mitigating the risk of exposure to COVID-19 for students and staff. Continuous evaluation and risk assessment in collaboration with local public health, and El Dorado County Public Health, will provide for the District to transition to a Traditional School Model or a Distance Learning Model as allowed/required by the county or state.

#### **Distance Learning (PreK-12)**

Due to health and safety concerns, schools are required to be closed for a short duration of time. Distance learning occurs when the learner and instructor, or source of information, are separated and students receive synchronous and asynchronous instruction five days per week remotely. Additionally, some in-person learning will occur for the most at-risk populations.

#### **Hybrid Learning (PreK-12)**

Hybrid learning is a combination of in-person learning in a classroom (or other physical space) and distance learning. Smaller cohorts of students participate in in-person instruction, on a designated schedule and campus, two to three days per week, and two to three days per week of at-home distance learning.

#### **Modified Traditional (PreK-12)**

A Modified Traditional Model allows for enhanced safety protocols to include minimal intermixing of cohorts of students. Teachers remain with individual cohorts, minimizing movement of students and staff as much as possible. Limiting group gatherings and shared common space, physical distancing in classrooms, enhanced safety and hygiene practices to include masking when physical distancing is not possible, increased hand washing, and health screening with illness response protocols will be in place.

#### **Traditional School (PreK-12)**

The teacher and students meet physically in their school settings in the manner they did prior to the pandemic with appropriate safety protocols.


## **Elevated Digital Learning Academy (TK-8)**

Elevated is a digital learning academy under Lake Tahoe Unified School District (LTUSD) offering students in grades Transitional Kindergarten through 8th, an online, comprehensive, educational program. Instruction will be delivered entirely online through regularly scheduled, live instruction with district teachers and prerecorded lessons. Curriculum is fully aligned to California state standards and content is the same as that taught at LTUSD school sites.

## Academic Success

Each instructional model will ensure that both in-person and distance learning are robust and offer equal educational access, opportunity, and continuity. Consideration for instructional planning leading to successful implementation, and the reaction of a learning environment that provides the instructional supports, relevant and accessible curriculum, and materials is our highest priority. LTUSD ensures academic success in order to:

- Provide optimal learning opportunities for all students
- Prioritize our most in-need students
- Address the social-emotional needs of students by focusing on Social Emotional Learning, Connectedness, and Engagement
- Assess learning loss and/or learning gains to mitigate, intervene, and accelerate student learning outcomes
- Establish protocols for authentic assessment, progress monitoring, and authentic learning
- Accelerate learning versus remediate learning by embedding prior year content into current year standards and context
- Develop habits of mind that promote independent learning





# Social Emotional Support

Relationships and in-person connectivity are a critical component of social development for students. LTUSD will provide comprehensive social emotional learning supports and strategies. LTUSD recognizes that the impact of the COVID-19 Pandemic has increased the traumatic experiences and stress on the staff and students and emotional recovery planning is necessary for establishing positive, safe and supportive learning environments. LTUSD's commitment to Social Emotional Learning shall:

- Create environments that allow staff and students to navigate the unprecedented challenges of alternative learning and instructional models.
- Build skills necessary for enhancing self-management skills, resilience, and connections.
- Provide staff and students with comprehensive training and instruction in SEL.
- Establish a crisis response team focused on student and staff mental health and wellness.
- Assess natural resources (personnel, existing partners) to determine if there is a need for external support, and reach out to the existing community providers to assess the potential for expanded work.
- Evaluate staff mental health readiness utilizing questionnaires, surveys, and direct outreach.
- Provide resources for staff self-care, including resiliency strategies.



# Health and Safety

Our schools must provide a safe and supportive learning environment that ensures access to the appropriate Personal Protective Equipment, implements health screens and protocols to prevent the spread of COVID-19, and establishes and educates staff and students on Healthy Hygene Practices. When in person learning instructional models are implemented the District will follow the guidance of the CDC, CDPH, county and local health authorities. Current recommendations ensure the that the following guidance will be implemented across all educational environments:

- Face coverings must be used in accordance with CDPH guidelines unless a person is exempt.
- Face coverings (masks/shields) are required for grades 3-12.
- Face coverings (masks/shields) are strongly encouraged for grades Preschool, TK-2nd.
- Face coverings (masks/shields) are required and will be provided for all staff members.
- Face coverings (masks/shields) will be provided for all preschool programs and grades TK-2.
- Staff members and students may bring their own PPE as long as it complies with public health guidelines.
- Face coverings are not required for persons with a medical condition, mental health condition, or disability that prevents them wearing a face covering. This includes persons with a medical condition for whom wearing a face covering could obstruct breathing or who are unconscious, incapacitated, or otherwise unable to remove a face covering without assistance.
- Face coverings are not required for persons who are hearing impaired, or when communicating with a person who is hearing impaired, where the ability to see the mouth is essential for communication.
- Plexiglass barriers and/or face shields with neck drapes will be provided for staff members who encounter situations of a proximity of less than six (6) feet between individuals, or those who support multiple cohorts.
- Healthy Hygiene Practices (hand washing; avoiding contact with one's eyes, nose, and mouth; and covering coughs and sneezes) will be taught and reinforced.
- Routines will be established to help students and staff regularly wash their hands at staggered intervals (e.g., upon arrival, before and after meals or snack time, before and after going to the restroom, etc.)
- Self-screening for daily symptom monitoring will be conducted prior to students and staff coming to school.

## **Physical Distancing and Movement**

- Teachers and students should remain in the same space and in cohorts as small and consistent as practicable, including recess and lunch.
- The space between seating and desks will be maximized. Seating will be arranged to minimize face-to-face contact, and physical partitions will be used where needed.
- Physical distancing >6 ft is recommended for all student-staff interactions, staffstaff interactions, and student-student interactions.
- Unidirectional pathways and staggered passing times will be created in order to help maintain physical distancing requirements in all common walkways and congregation areas (both outdoor and indoor).
- School sites will identify multiple access points to be used for student and parent ingress and egress before and after school.
- Pick up and drop off times, recess, and lunch times will be staggered and designed to maintain physical distance requirements to maintain cohort stability.

## **Cleaning**

- A schedule will be developed for increased, routine cleaning and disinfection.
- Adequate supplies (e.g., alcohol based hand sanitizer, gloves, disinfecting wipes, tissues, and no-touch trash cans) will be provided to support healthy hygiene behaviors.
- All staff will be trained to regularly clean and disinfect high touch areas and surfaces in their work areas in accordance with the Centers for Disease Control (CDC) guidance for schools and childcare centers.
- Frequently touched surfaces (e.g., playground equipment, door handles, sink handles, drinking fountains) within the school and on school buses will be cleaned and disinfected at least daily or between use as much as possible.
- Use of shared objects (e.g., gym or physical education equipment, art supplies, toys, games) should be limited when possible, or cleaned between use.
- Shared site resources (e.g., drinking fountains) may be suspended. Personal reusable water bottles are encouraged.
- If transport vehicles (e.g., buses) are used by the school, drivers will practice all safety actions and protocols as indicated for other staff (e.g., hand hygiene, cloth face coverings), and clean and disinfect school buses or other transport vehicles regularly.
- Cleaning and disinfecting products should be properly stored away from children. All products must meet EPA disinfection criteria.



- Cleaning products should not be used near children, and staff should ensure that there is adequate ventilation when using these products to prevent children or themselves from inhaling toxic fumes.
- If the school has an outbreak, sites will follow the Outbreak Management guidelines provided by the CDPH

## **Health & Safety Checks**

- Staff and students who are sick or who have recently had close contact with a person with COVID-19 should stay home.
- Each site may consider doing symptom screenings, visual wellness checks, and/or temperature checks via touchless thermometer for all staff and students entering the facility. If an individual's temperature is above 100.4 degrees, they should be excluded from participation.
- Signs of Illness During School:
- Students and staff should be monitored for signs of illness throughout the day including:
  - Headache or tiredness, unable to participate in routine activities or need more care than staff can provide
  - Fever with behavior changes, difficulty breathing, uncontrolled coughing, unusually tired, persistent crying, etc.
  - Open sores, rash, signs of infection, etc.
  - Runny nose with colored mucus
- If a student (or staff member) exhibits any of the above symptoms, they will be physically separated from the group and will be required to wear a mask until they can be safely transported home or to a healthcare facility. Each site should have a designated isolation area where individuals exhibiting symptoms could be safely separated from the larger group.
- Parents / guardians are required to and must agree to come pick up their child without delay if they are exhibiting these symptoms.



## Governance

As the district implements the flexible instructional models, guidance for the governance and operations infrastructure will be followed. Transportation, Nutrition and Food Services, Maintenance of Facilities and Grounds and Custodial responsibilities ensure the safe implementation of each distance, in person and traditional learning model.

## **Facilities and Grounds**

- Ensure ventilation systems operate properly and increase circulation of outdoor air as much as possible, for example, by opening windows and doors. If opening windows poses a safety or health risk, maximize central air filtration for HVAC systems.
- Thorough cleanings will be conducted when children are not present. When cleaning, air out the space before children arrive. If using air conditioning, use the setting that brings in outside air. Replace and check air filters and filtration systems to ensure optimal air quality.
- Doors to rooms should remain open to help prevent contact with surfaces such as door handles, doors and door jambs.

## **Custodial and Maintenance**

- Ensure adequate supplies to support healthy hygiene behaviors, including soap, tissues, no-touch trash cans, face coverings and hand sanitizers with at least 60 percent ethyl alcohol for staff and children who can safely use hand sanitizer.
- Staff should clean and disinfect frequently-touched surfaces within school and on school buses at least daily and, as practicable, frequently throughout the day. Frequently touched surfaces in the school include, but are not limited to:
  - Door handles
  - Light switches
  - Sink handles
  - Bathroom surfaces
  - Tables
  - Student Desks
  - Chairs
- When choosing cleaning products, use those approved for use against COVID-19 on the Environmental Protection Agency (EPA)-approved list "N" and follow product instructions.



## **Food Services**

- Physical distancing shall be maintained between students, between staff and students, and between all staff during their lunch period(s).
- Children are encouraged to bring their own meals as feasible, or individually plated meals will be served in classrooms instead of in the cafeteria, while ensuring the safety of children with food allergies.
- To the maximum extent possible food service items (e.g., utensils, dishes)
  will be used. If disposable items are not feasible or desirable, all nondisposable food service items will be handled with gloves and washed with
  dish soap and hot water or in a dishwasher. Individuals should wash their
  hands after removing their gloves or after directly handling used food service
  items.
- Meals will be served in classrooms or outdoor areas instead of cafeterias where practicable. Individually plated or bagged meals will be served. Sharing foods and utensils and buffet or family-style meals should be avoided.
- If food is offered at any event, pre-packaged boxes or bags will be offered for each attendee. Avoiding the sharing of food and utensils ensures the safety of children with food allergies.

## **Transportation**

- Buses should be thoroughly cleaned and disinfected daily and after transporting any individual who is exhibiting symptoms of COVID-19. Drivers will be provided disinfectant wipes and disposable gloves to support disinfection of frequently touched surfaces during the day.
- Drivers should be a minimum of 6 feet from students and must wear face coverings.
- Students (preschool -12) must wear facial coverings while on the bus; unless exempt.
- Assigned seating by cohort will be encouraged.
- Symptom screenings should be performed by parents prior to being dropped off at the bus.
- Open windows for increased ventilation will be encouraged (weather permitting).
- Alternative modes of transportation will be encouraged for students who have other options.

# Special Populations

# Special Education and Special Populations including English Learners, students who are Medically Fragile and At-Risk Students

The district is preparing a flexible instructional platform to include multiple instructional models that ensure the needs of all students are met. The district will ensure students with disabilities and other special populations are fully integrated into every aspect of planning consideration in order to ensure the educational benefit to students and their families. In order to honor the diversity of need within our student population the district will:

# Considerations for Students on IEPs, 504s, English Learners, and At-Risk Students:

- Prioritize the health and safety of students and staff, as guided or directed by public health officials.
- Provide academic support and access to ensure educational progress.
- Continue with goals for English learners to achieve the same rigorous gradelevel academic standards that are expected of all students
- Provide a comprehensive program of designated and integrated English language development (ELD) instruction targeted to their proficiency level and will include assessment of proficiency and support access to curriculum.
- Establish protocols to reclassify students as fully English Proficient will be provided to be utilized across all Models of Instruction.
- Implement distance learning plans for each individual student which will provide an explanation of how the student's IEP will be executed in that model of instruction. Because a distance learning instructional model is different from an in-person instructional model there will be obvious variations in how the IEP will be executed.
- Ensure service minutes align with the IEP frequency/duration to the greatest extent possible. As a result of SB 98, there is a legislative expectation that school districts develop distance learning instructional models that ensure that IEPs are executed in that instructional model.
- At all initial IEP team meetings and at all regularly-scheduled IEP team meetings for students with existing IEPs, the IEP team must include a description of the means by which the IEP will be provided under emergency conditions in which instruction or services, or both, cannot be provided at

- the school or in person for more than 10 school days.
- Assessments are critical to the IEP process and should not be compromised due to current limitations. If assessors believe that in-person assessments are a necessary part of an assessment, they should take steps to conduct in-person assessments in compliance with all state and local health directives and guidelines.
- Develop and implement a plan to provide in-person instruction to those students who cannot reasonably access distance education.

## **Students with Significant Health Needs**

Students who have significant health needs may be at higher risk for severe illness. Based on currently available information and clinical expertise, students who have serious underlying medical conditions might be at higher risk for severe illness from COVID-19. Groups that might be at increased risk of becoming infected or having unrecognized illness include the following:

- Individuals who have limited mobility or require prolonged and close contact with others, such as direct support providers and family members.
- Individuals who have trouble understanding information or practicing preventive measures, such as hand washing and physical distancing.
- Individuals who may not be able to communicate symptoms of illness.
- Underlying medical conditions, include:
  - People with chronic lung disease or moderate to severe asthma.
  - People who have serious heart conditions.
  - People who are immunocompromised.
  - Many conditions can cause a person to be immunocompromised, including cancer treatment, smoking, bone marrow or organ transplantation, immune deficiencies, poorly controlled HIV or AIDS, and prolonged use of corticosteroids and other immune weakening medications.
  - People with severe obesity.
  - People with diabetes.
  - People with chronic kidney disease undergoing dialysis.
  - People with liver disease.

- Identifying the requirements of PPE for the differing populations of Students with Disabilities.
- If additional equipment is needed, provide guidelines and training for the use of new equipment.
- Develop a plan to further support students with access and functional needs who may be at increased risk of becoming infected or having unrecognized illness due to COVID-19.
- Review existing student health plans to identify students who may need additional accommodations, develop a process for engaging families for potentially unknown concerns that may need to be accommodated or identify additional preparations for classroom and non-classroom environments as needed.

## **Monitor and Plan for Absenteeism**

- Identify critical job functions and positions (such as SDC teachers, health aides, nurses, etc.) and plan for alternative coverage or cross-train staff when feasible.
- Determine what level of absenteeism will disrupt continuity of teaching and learning.
- Written tiered reengagement strategies for students who are absent from distance learning for more than 3 school days or 60% of the instructional days in a school week.
